There is a growing professional and public interest in the ethics of nursing care, and in the moral dilemmas with which nurses are often faced.

**Nursing Ethics**, written by a nurse, a philosopher and a theologian, presents an interprofessional approach to this important topic.

It begins with a general introduction to ethical questions, followed by two chapters on being a nurse, written by a nurse/sociologist. The authors then consider moral dilemmas related to the following:

- the nurse-patient relationship
- nursing particular groups of patients
- the nurse's role in society

These topics are considered within the framework of moral philosophy. A final chapter discusses some theoretical and practical aspects of the ethics of nursing care.

**Nursing Ethics is intended for general readership by all nurses, but all those studying the subject on a special course as part of their curriculum will find it particularly useful. It will also be an invaluable work for all those in the caring professions.**

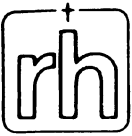

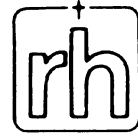

## Mason and McCall Smith: Law and Medical Ethics

1983

By **J. K. Mason**, CBE, MD, FRCPath., DMJ, Regius Professor of Forensic Medicine University of Edinburgh and **R. A. McCall Smith**, LLB. Ph.D. Lecturer in Civil Law, University of Edinburgh.

This topical book looking at the ethical and legal problems raised by new medical techniques is the first of its kind to be written jointly by a doctor and a lawyer, and as such it presents a broadly based, balanced study of medical jurisprudence. Medical ethics have in the past generally been approached from the viewpoint of the philosopher or social scientist. In this work Professor Mason and Dr McCall Smith choose a wholly different perspective and present an analysis of ethical concepts based on positive legal principles and court decisions. The book deals with a wide range of potentially difficult situations in which the community, as represented by the law, may come into conflict with the medical profession. **Mason and McCall Smith: Law and Medical Ethics** will prove invaluable to law students taking courses in medical jurisprudence and of compelling interest to all concerned with the complex relationship between the law and medical practice.
