This book is intended for all those who see a need for critical thinking about the moral issues which arise in medical practice, including many doctors, nurses and other health workers, who acknowledge no such requirement. Either they are confident of knowing all they need to know, or they are content to rely on received wisdom, or they think such issues are irrelevant in practice.

Each group will find its views challenged in this book. The author believes that it is necessary to consider the relevance of four moral principles — respect for autonomy, beneficence, non-maleficence, and justice — with each ethical problem we encounter.

The book does not attempt to provide answers to specific medico-moral problems, but it does seek to bring more order, consistency and understanding to moral judgements in health care.
