#### Submitting manuscripts for publication

Papers submitted for publication should be sent in duplicate to Dr A V Campbell, the Editor, Journal of medical ethics, University of Edinburgh, New College, The Mound, Edinburgh EH1 2LX. They should be in double-spaced typewriting on one side of the paper only. On the paper the name of the author should appear with initials or distinguishing christian name and the address to which editorial communications should be sent.

Abbreviations should be avoided except for those in general use. The names of journals, organisations, etc, should be printed in full.

#### References

In the list of references at the end of a paper each should be numbered in the order in which each reference appears in the text, and these numbers should be shown as superscripts in the text itself: thus, for example, in the text Bowden<sup>1</sup> and in the list <sup>1</sup> Bowden, Paul (1976), Journal of medical ethics, 2, 163–172. A reference to a book would also be indicated in the text by a number set above the line and quoted in the list by that number thus: <sup>1</sup> Abel-Smith, Brian (1976), Value for Money in Health Services. London. Heinemann. However, exceptions will be made when references are quoted according to the common practice of a particular discipline, eg, the law, when to alter these would cause confusion to specialists likely to use the reference list.

#### The chance of a lifetime - 1980

Churchill Travelling Fellowships are open to all UK citizens of any age or occupation, and since no educational or professional qualifications are needed, they are of special interest to people who would not be eligible for other types of grants. (Churchill Fellowships are not normally given for academic studies).

The object of the awards is to enable those who would not otherwise have a chance, to gain a better understanding of the lives and work of people in countries overseas, and to bring back useful knowledge, skill and experience for the benefit of our community. About 100 awards are made annually, and there are now nearly 1300 Churchill Fellows.

Grants are offered in different categories each year; candidates whose trade, profession or interest are covered by any of them may propose a project they wish to carry out in whatever countries they choose. The only requirement is that they have to show that they can make effective use of the opportunity both while they are abroad and when they return. The 1980 Award categories include voluntary service workers and organisations, provision of care for latchkey children, and community health workers. A full list is available from the address given below.

The final selection for the next group of awards will be made by interview in London in January 1980. Successful candidates will be expected to start their travels during that year, making their own plans and arrangements within the scope of the grant. The grant will cover return air fare, plus all travel and living expenses abroad for a period of up to three months.

#### Health care for the single homeless: report of medical services study day

The Scottish Council for Single Homeless is a national voluntary organisation funded by the Scottish Office and local authorities and concerned with promoting the welfare of the single homeless. The Council is releasing a report of a study day organised about medical services for the single homeless which contains the texts of the talks given which, in spite of the eighteen month time lapse, are still very relevant. The Council's own recommendations to the health boards, the Scottish Home and Health Department, local authorities and voluntary organisations form the conclusion of the report.

Of particular concern are the difficulties that many single homeless have in obtaining primary medical care, i.e. general practitioners' services, so crucial to all the community and therefore very serious for a section with a known high rate of morbidity and low rate of registration with general practitioners. A high incidence of complaints about feet, chest disease, psychiatric disorders and alcohol related problems were among the long lists of illnesses presented and diagnosed. Special schemes that operate in different kinds of ways in Aberdeen, Edinburgh and Glasgow are described, but none of the contributors would claim their local provisions were a complete substitute for the National Health Service. Previously it was common practice for a single homeless person with a minor ailment to

attend the 'accident and emergency' department of the general hospital which tended to be ill equipped as far as records and continuity of case were concerned.

The report is being submitted to all health boards with the request that they ensure all single homeless have access to the normal medical services and that they should be encouraged to use the services. Additionally the Scottish Home and Health Department is being asked to take a more active part than it has done to date in promoting adequate facilities throughout the country until the needs of the single homeless are wholly met by the normal NHS facilities.

# Society for the Study of Medical Ethics

The Society for the Study of Medical Ethics is an independent, non-partisan organisation for the multidisciplinary study of issues raised by the practice of medicine.

The Society aims to influence the quality of both professional and public discussion of medico-moral questions; to promote the study of medical ethics; to ensure a high academic standard for this developing subject; to encourage a multidisciplinary approach to discussion of the consequences of clinical practice; to stimulate research in specific problems; to remain non-partisan and independent of all interest groups and lobbies.

Since 1963 the London Medical Group, a student group for the study of issues raised by the practice of medicine, has arranged a series of lectures and symposia, now twice weekly throughout the academic year, in the 12 London teaching hospitals and medical schools.

In 1967 the Edinburgh Medical Group was established with similar aims, and subsequently medical groups have been formed in a majority of the British medical schools—currently Newcastle, Sheffield, Glasgow, Bristol, Birmingham, Manchester, Liverpool, Cardiff, Southampton, Aberdeen, Dundee, Cambridge and Oxford.

In 1972 junior doctors, who had themselves been associated with the London Medical Group, founded the Society for the Study of Medical Ethics to develop these aims at a postgraduate level.

In 1975 research fellows were appointed by the Edinburgh Medical Group which has established, in conjunction with the University of Edinburgh, a research project in medical ethics and education. This is funded by the Leverhulme Trust Fund and the Nuffield Provincial Hospitals Trust.

The Society for the Study of Medical Ethics is a registered educational charity and a Company Limited by Guarantee. It relies on voluntary grants and donations and is not supported from government sources.

There is no individual membership of the Society. Those interested in this work are invited to subscribe to the Journal of medical ethics. The lectures, symposia and conferences of the associated medical groups, although addressed primarily to medical, nursing and other students, are open to all those professionally interested. Details are published in the Journal.
